

ELECTIONS OF REPRESENTATIVES OF STUDENT PARENTS TO THE SCHOOL COUNCIL

This council is competent:

- for everything relating to pedagogical and educational matters;
- adoption of the school project, internal regulations, timetables and the calendar for the school year, the annual guidance education plan, the continuing training plan for staff.
- on questions of hygiene, safety, working conditions of staff;
- on questions relating to the reception and information of parents of pupils, the general modalities of their participation in the life of the LGM

Electoral list :

The list of parents of students constituting the electorate is drawn up at least fifteen days before the date of the elections. It is deposited with the Headmaster's secretariat. Voters can check their registration on the list and ask, if necessary, the Headmaster to correct an omission or error concerning them.

15 seats to be filled: 15 representatives of parents of students, including at least one per level of education.

Voting rights

Parents - two votes per family - with one or more children in school are voters. Where applicable, only the parent who has parental authority is a voter.

Voting method:

Each voter can vote:

- Either on polling day during the opening hours of the polling station indicated above,
- Or by correspondence, under the following conditions:
 - ❖ The ballot paper, without erasure or overprinting, must be inserted in an envelope provided that does not bear any inscription or identification mark. This sealed envelope is slipped into the second envelope, sealed in turn, on which are written on the front the address of the school and the words "elections of parents' representatives to the school council" and on the back, the elector's surname and first name as well as his address and signature.
- ❖ **The postal vote can be sent by the children themselves; the envelope is then deposited at the headmaster's secretariat. Deadline for the submission of postal votes is 25/10/2021 until 4:00 p.m.**
 - ❖ Any envelope not bearing the above mentioned information will be set apart without being opened, cannot give rise to signing on the electoral list and consequently will not be taken into account to calculate the number of voters.
- ❖ In accordance with the BO Education Code No. 29 of July 22, 2004. Procedures for designation of EPLEs to the Board of Directors, proxy voting is not allowed.
